# Job Title: Program Director

## General Description:

- This is a full-time, year-round salaried position.

## Major Responsibilities:

- Plan and implement safe, accessible sport, recreation, and wellness activities.
- Implementation and provision of therapeutic recreation services to clients in homes or community settings.
- Describe and present therapeutic recreation services to consumers, families, colleagues, related services and community service providers, in the private sector, school systems and Veterans Affairs systems.
- Coordinate contracts with vendors seeking community-based therapeutic recreation services and manage collaboratively with the program team, all contract requirements, including staffing, and documentation
- Perform formative program evaluation.
- Identify organizational volunteer staffing needs, recruit volunteers, manage volunteer staff and coordinate volunteer assignments.
- Work with Training Coordinator to identify needs for new and/or revised training activities.
- Work with Equipment Coordinator in identifying and researching adaptive equipment needs.
- Participate in development and maintenance of operational guidelines.
- Provide budget and financial planning information to Executive Director as requested. Provide regular activity reports to Executive Director.
- Participate in general planning activities with Executive Director, management team, and Board of Directors.
- Support various communication, fundraising, and community outreach activities. Act as spokesperson for the organization and complete outreach activities as requested.
- Stay current with various developments in the non-profit and adaptive worlds through research and educational activities, including continuing education, networking, and membership in professional organizations.
